Capital Beltway Express LLC ("**CBE**") a partnership of Transurban Drive and Fluor Corporation is issuing this Request for Qualifications (the "**RFQ**") to solicit qualifications ("**Qualifications Submissions**") from those entities ("**Potential Offerors**") interested in contracting for the architectural/engineering design for the renovation of an existing 29,000 square foot building to accommodate the future HOT Lanes Operations Center (HOT-OC) (the "**Project**"). The HOT Lanes are 14 miles of toll road being constructed from just north of the Dulles Toll Road to the Springfield interchange with 395/95 on the 495 Capital Beltway in Virginia, USA. The existing building to accommodate the future HOT-OC is located at 6440 General Green Way, Alexandria, VA 22312 (the building is still occupied by the current tenant). This RFQ establishes the process for determining which Potential Offerors will be invited to submit proposals for the project. Proposals will be solicited from only a short-list of Potential Offerors determined to be the most qualified to complete the Project ("**Short-List**").

CBE intends to procure design service for the architectural and engineering of the existing building upgrade for the future HOT-OC under a single contract. The Successful Offeror will be responsible for all efforts required for the design of the base building renovations and tenant improvements required to meet the needs of the HOT-OC, including architectural, structural, mechanical, plumbing and electrical design. The scope of work for the Project will include:

- Design for the renovation of the existing building shell shall include but not limited to:
 - Exterior modifications to reflect the corporate branding of the company,
 - replacement of windows and doors,
 - raising the roof within a defined area to accommodate the control room,
 - new mechanical, plumbing and electrical infrastructure;
 - addition of a wet sprinkler system,
 - new roofing;

- Design for the tenant improvements will include but not limited to:
 - areas of open floor plan offices,
 - closed offices,
 - operational traffic control room,
 - computer/data room,
 - conference rooms,
 - training rooms,
 - restrooms with showers,
 - break room,
 - storage facilities

- other areas typically found in standard office spaces;
- Design for both the based building renovation and tenant improvements shall use sustainable materials, equipment and construction practices required in receiving LEED certification. The level of certification will be based on a cost benefit analysis.
- Coordination and design of the required mechanical and electrical infrastructure required to support the installation of the TTMS (Tolling and Traffic Management System).

Other Project requirements include proximity of the Architect’s office where the work is to be performed will be within 30 miles of CBE’s offices located at 1421 Prince Street, Suite 200, Alexandria, VA 22314.

Potential Offerors should provide the following details in their Qualification Submission since these areas will be evaluated in the short-list selection process. Each of the qualifications will be evaluated and assigned a numerical value equal to or proportional to the total available points assigned to that qualification:

- Letter of interest confirming the official representative and point of contact for the Offeror relative to this RFQ. The letter shall identify such individual’s name, title, address, phone and fax numbers, and e-mail address.
- Client references for previous projects, including current contact information.

Any agreement between a consultant and a DBE firm whereby the DBE firm promises not to provide services to other consultants is prohibited. The DBE contract goal for this procurement is 15%.
